# Introduction

**P**artnering with schools — public school systems, private and parochial schools, charter schools, daycare centers and pre-schools, or Head Start programs — can be a great way to reach and enroll families with children who are eligible for Medicaid or the Children’s Health Insurance Program (CHIP) and not yet enrolled. Cultivating relationships with school staff is a win-win — we know that students are better equipped to learn when they’re getting the health care they need, and schools are trusted sources of information for parents. Connecting with schools can open up opportunities for countless outreach and enrollment activities throughout the year to get — and keep — kids covered.

Back in March 2020, the Centers for Medicare & Medicaid Services (CMS) temporarily waived certain Medicaid and CHIP requirements and conditions. The easing of these rules helped prevent people with Medicaid and CHIP — in all 50 states, the District of Columbia, and the five U.S. territories — from losing their health coverage during the COVID-19 pandemic and many people have not had to renew coverage during this time. States are now returning to normal operations and restarting eligibility reviews. This means millions of adults and children could lose their Medicaid or CHIP coverage between now and May 31, 2024.

It is important to remind people still enrolled in Medicaid or CHIP to: (a) update their contact information with their state Medicaid or CHIP agency, (b) respond to the Medicaid/CHIP renewal form when it arrives in the mail to maintain coverage, and (c) consider other coverage options: if families are no longer eligible for Medicaid or CHIP, they can see if they can get coverage through their employer or through the Health Insurance Marketplace at HealthCare.gov.

Remember, parents should respond to renewal letters if they don’t think they’re eligible — their kids could still be eligible! Many children may lose coverage due to simply missing the application in the mail.

According to some estimates, up to **15 million** people could lose their current Medicaid or CHIP coverage during this process. In an effort to minimize the number of people that lose Medicaid or CHIP coverage, CMS is working with states and other stakeholders on outreach efforts like this Back-to-School initiative to inform people about renewing their coverage and exploring other available health insurance options if they no longer qualify for Medicaid or CHIP.

# Key Messages

## Back-to-School is an Important Time to Talk Health Coverage

Having health insurance is critical for children to thrive at school and in life. Children with health insurance are more likely to complete high school and graduate college compared with their peers who don't have access to care.

Health coverage for kids benefits everyone. Studies have shown that children with health coverage are less likely to miss school due to illness and are better prepared to learn, meaning fewer missed days of work for parents. Fewer missed school days may also allow kids and teens to stay involved with after-school activities like clubs and sports.

## Get Ready to Renew Now

Enrollees who have Medicaid or Children's Health Insurance Plan (CHIP coverage) should update their contact information with their state Medicaid or CHIP agency and fill out and return the renewal form when it arrives in the mail to avoid a gap in coverage.

## Other Important Enrollment Messages

Medicaid and the Children's Health Insurance Program (CHIP) [**NAME OF STATE CHIP PROGRAM**] **offers free or low-cost health insurance** for children and teens up to age 19 in families with low and moderate incomes.

Eligibility is dependent on household size and income and varies by state. In most states, children up to age 19 with family income up to \$60,000 per year (for a family of four) may qualify for Medicaid or the CHIP. In many states, family income can be even higher and children can still qualify. Young people up to 21 may be eligible for Medicaid.

Families can enroll in either program at any time throughout the year. Other family members may have to enroll in a Qualified Health Plan through the Marketplace. Many uninsured children may be eligible for coverage, but their parents don't know it.

Even if you work or have applied for free or low-cost health coverage from your state before and haven't qualified, you and members of your household may now be eligible.

Parents and other adults may qualify for Medicaid as well. And even if you are not eligible, your child may be.





If your child no longer qualifies for Medicaid, you may be able to get them health coverage through your state’s CHIP.

Losing Medicaid or CHIP coverage is a [Qualifying Life Event \(QLE\)](#), which allows you to enroll in a Marketplace plan outside of the Open Enrollment Period.

Families and individuals can apply online, by phone, by mail or in person. Enrollment is open year-round, and coverage must be renewed each year to keep children enrolled in Medicaid and CHIP.

The process to apply for free or low-cost health coverage for your child from your state has gotten faster — many can apply and find out if they qualify the same day.

## Benefits

For children and teens, Medicaid and CHIP cover immunizations, prescriptions and emergency doctor visits. Other benefits include check-ups and regular doctor visits, dentist visits, mental and behavioral health services, eye exams, and other care children and teens may need.

Children with Medicaid and CHIP have coverage for age-appropriate vaccinations and the seasonal flu vaccine each year.

Services are covered through Medicaid for children and teens up to age 21 and in CHIP up to age 19.

## **Make sure your child has all the essentials for a productive school year**

Studies have shown that academic performance and health insurance go hand in hand. Children who have health coverage miss fewer classes and perform better in school than those who are uninsured. But health coverage doesn't just benefit students. Fewer missed days of school also mean fewer missed days of work for parents. With health coverage, children can get the routine and emergency care, immunizations, check-ups, eye exams, dental visits and mental health services they may need to fully participate in school and extracurricular activities.

Nationwide, millions of school-aged children and teens qualify — and are enrolled — in free or low-cost health coverage through Medicaid and the Children's Health Insurance Program (CHIP). You can help them keep their coverage by reminding them to make sure their current mailing address, phone number, and other contact information are up-to-date with their state program. Many families may have moved and forgotten to update their address with their state program. These families might accidentally miss a letter about coverage from their state program, including renewal information. Then, they could lose their health coverage too. Remind families to check their mail for a renewal letter, complete it, and return it right away

Medicaid and CHIP provide free or low-cost coverage for eligible children and teens up to age 19. Eligibility is dependent on household size and income. In most states, children whose family has income up to \$60,000 per year (for a family of four) may qualify for Medicaid or CHIP. In many states, family income can be even higher and children can still qualify. Young people under 21 may be eligible for Medicaid. Having Medicaid or CHIP will not affect someone's chance of becoming a Lawful Permanent Resident or U.S. Citizen. It is not considered a "public charge" except for people in long-term care facilities or institutions.

Families can apply online, over the phone, by mail or in-person with your state's Medicaid or CHIP agency or visit the "Find Coverage for Your Family" section on [InsureKidsNow.gov](https://www.insurekidsnow.gov). For more information, families can call 1-877-KIDS-NOW (1-877-543-7669). Enrollment in Medicaid and CHIP is open all year, and, child is enrolled, families need to renew their coverage every year to keep them covered.

## **Asegúrese de que su hijo tenga todos los elementos esenciales para un año escolar productivo**

Los estudios han demostrado que el rendimiento académico y el seguro médico van de la mano. Los niños que tienen cobertura de salud faltan menos a clases y se desempeñan mejor en la escuela que aquellos que no tienen seguro. Con cobertura de salud, los niños pueden obtener atención de rutina y de emergencia, vacunas, chequeos médicos, exámenes de la vista, consultas dentales y los servicios de salud mental que pueden necesitar para participar plenamente en la escuela.

Medicaid y CHIP proporcionan cobertura gratuita o de bajo costo para niños elegibles hasta los 19 años. La elegibilidad depende del tamaño de la familia y de los ingresos. En la mayoría de los estados, los niños con ingresos familiares de hasta \$60,000 por año (para una familia de cuatro) podrían calificar para Medicaid o CHIP. En muchos estados, los ingresos familiares pueden ser aún más altos y los niños aún podrían calificar. Los jóvenes menores de 21 años podrían ser elegibles para Medicaid. Tener Medicaid o CHIP no afectará la posibilidad de que alguien se convierta en residente permanente legal o ciudadano estadounidense. No se considera solicitar o tener Medicaid o CHIP una determinación de “carga pública” para las personas en centros o instituciones de cuidado a largo plazo.

Reach out to local radio stations to spread the word about Medicaid and CHIP! The following scripts are designed to be read by local radio personalities when free airtime is available. 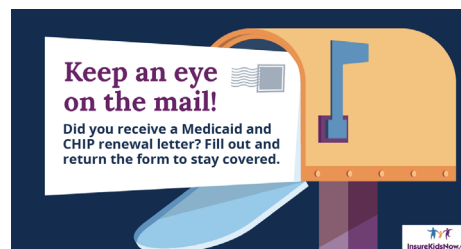

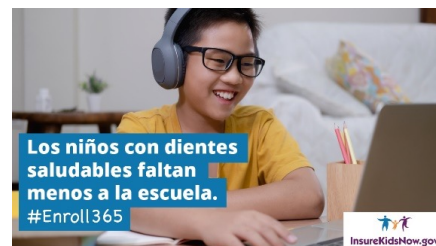

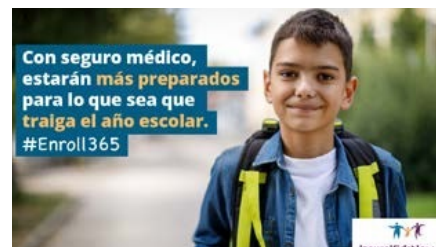
